IMPORTANT ELECTION DATES

GENERAL ELECTION OF CITY OFFICERS MAY 2, 2026

Wednesday January 14, 2026	First day for filing an application for a place on ballot; and, first day for filing declaration of write-in candidacy for the General election.
Monday January 20, 2026 to Friday February 13, 2026	Recommended period and statutory deadline for ordering the election. <i>The City of Humble will order the election during the Thursday, January 22, 2026 or Thursday, February 12, 2026 regular City Council meeting at 6:30 p.m. The official agenda will be posted to the City's website (https://www.cityofhumbletx.gov/council-meetings/) at least three (3) business days prior to the scheduled meeting date.</i>
Friday February 13, 2026	Last day to file application for place on ballot in the General election. (Must be received by 5:00 p.m.)
Tuesday February 17, 2026	Last day for a write-in candidate to declare candidacy in the General election. (Must be received by 5:00 p.m.)
Friday February 20, 2026	Last day for a ballot or write-in candidate in General election to <u>withdraw</u> and have name removed. (Must receive in writing by 5:00 p.m.)
Thursday February 19, 2026 to Monday February 23, 2026	Recommended period to conduct a drawing for the order of names on the ballot. The drawing is scheduled for 10:00 a.m. on February 19, 2026, at the City of Humble Council Chambers, 114 W. Higgins St., Humble, Texas 77338. <i>(Candidates will be informed of any changes to the date.)</i>
Thursday April 2, 2026	1st report of Candidate/Officeholder Campaign Finance Report due by 5:00 p.m., or midnight if filed electronically, by opposed candidates and specific-purpose committees supporting or opposing candidates. This is the 30-day prior to Election Day report.
Thursday April 2, 2026	Last day for submitting voter registration application to Harris County in time to vote at the election or for requesting transfer of registration in time to vote in new precinct not in the same county and territory.
Thursday April 2, 2026 to Wednesday April 22, 2026	Period for publishing the notice of election in the newspaper. <i>Tentative plans are to publish the notice in the Wednesday, April 8, 2026, edition of the Humble Observer newspaper.</i>

Sunday April 19, 2026 6:00 p.m.	Candidate political signs may be posted throughout the City of Humble on city owned or controlled property starting at 6:00 p.m. It is an offense for any person to leave any electioneering sign or literature on city-owned or -controlled property that is used as a polling place other than during the period beginning on 6:00 p.m. before the voting period begins.
Monday April 20, 2026	First day for early voting by personal appearance begins.
Monday April 20, 2026	Last day the Early Voting Clerk / City Secretary accepts an application for a ballot to be voted by mail by noon or close of business.
Friday April 24, 2026	2nd report of Candidate/Officeholder Campaign Finance Report due by 5:00 p.m., or midnight if filed electronically. This is the 8-day prior to Election Day report.
Tuesday April 28, 2026	Last day of early voting by personal appearance.
Saturday May 2, 2026	ELECTION DAY ** 7:00 A.M. TO 7:00 P.M.
Monday May 4, 2026 5:00 p.m.	Last day to receive mailed ballots if the carrier envelope arrives before 5 p.m. and has a cancellation mark indicating it was placed for delivery at or before 7 p.m. local time for the place of election. This deadline applies to voters who applied for a ballot by mail and cast a by-mail ballot from within the U.S.
Monday May 4, 2026 7:00 p.m.	Last day all candidate political signs <u>must</u> be removed throughout the City of Humble on city-owned or controlled property. It is an offense for any person to leave any electioneering sign or literature on city-owned or -controlled property that is used as a polling place other than during the period ending forty-eight (48) hours after the voting period ends.
Wednesday May 6, 2026	Deadline for winning candidates to inform the City Secretary whom will be swearing them into office. (Must receive in writing by 5:00 p.m.) <i>The City Secretary Department will confirm eligibly by or before the third business date.</i>
Tuesday May 5, 2026 to Wednesday May 13, 2026	Period for official canvass.
Tuesday May 5, 2026 to Saturday May 16, 2026	After canvass, recommended period to issue certificates of election, official statement of elected officer, and oath of office.

RUNOFF ELECTION OF CITY OFFICERS

JUNE 13, 2026

Thursday May 14, 2026	LAST DAY to register to vote for the runoff of this May election.
Thursday May 14, 2026 to Wednesday June 3, 2026	Period for publishing the notice of election in the newspaper. <i>Tentative plans are to publish the notice in the Wednesday, May 20, 2026, edition of the Humble Observer newspaper.</i>
Tuesday June 1, 2026	First day of early voting in person. <u>Texas Election Code § 52.094:</u> <i>The order of the names on the runoff ballot shall be in the relative order as they appeared on the general election ballot, no ballot drawing is required for the runoff ballot.</i>
Friday June 5, 2026	Runoff report of Candidate/Officeholder Campaign Finance Report due by 5:00 p.m., or midnight if filed electronically. This is the 8-day prior to Election Day report.
Tuesday June 9, 2026	Last day of early voting in person.
Saturday June 13, 2026	ELECTION DAY ** 7:00 A.M. TO 7:00 P.M.
Monday June 15, 2026 7:00 p.m.	Last day all candidate political signs <u>must</u> be removed throughout the City of Humble on city-owned or controlled property. It is an offense for any person to leave any electioneering sign or literature on city-owned or -controlled property that is used as a polling place other than during the period ending forty-eight (48) hours after the voting period ends.
