**CANDIDATE ELIGIBILITY REQUIREMENTS & DEADLINE TO FILE**

<b>STATE ELECTION CODE ELIGIBILITY REQUIREMENTS FOR PUBLIC OFFICE</b>	<b>CITY OF HUMBLE, TEXAS CHARTER ARTICLE II, THE CITY COUNCIL AND THEIR ELECTIONS</b>
<ol style="list-style-type: none"> <li>1. Must be a United States Citizen.</li> <li>2. Must be 18 years of age or older on the first day of the term to be filled at the election or on the date of appointment, as applicable.</li> <li>3. Have not been determined by a final judgment of a court exercising probate jurisdiction to be totally mentally incapacitated; or partially mentally incapacitated without the right to vote.</li> <li>4. Have not been finally convicted of a felony from which the person has not been pardoned or otherwise released from the resulting disabilities.</li> <li>5. Have resided continuously in the state for 12 months and in the territory from which the office is elected for six months immediately preceding the date of the regular filing deadline for a candidate’s application for a place on the ballot.</li> <li>6. On the date described by section (5), be registered to vote in the territory from which the office is elected.</li> <li>7. Satisfy any other eligibility requirements prescribed by law for the office.</li> </ol>	<ol style="list-style-type: none"> <li>1. The mayor and each councilmember shall be at least eighteen (18) years of age.</li> <li>2. Shall be both a qualified and a registered voter of the City of Humble for a period of at least one year immediately prior to the election.</li> <li>3. The mayor and councilmembers shall not hold any other elected public office.</li> <li>4. Failure of a member of the city council to maintain the residency requirement shall result in such office being automatically vacated.</li> </ol>
