ORDINANCE NO. 26-1007

AN ORDINANCE OF THE CITY OF HUMBLE, TEXAS, DECLARING UNOPPOSED CANDIDATES IN THE MAY 2, 2026, GENERAL CITY ELECTION AS ELECTED TO OFFICE; CANCELING CITY COUNCIL MEMBER PLACE 3, CITY COUNCIL MEMBER PLACE 4 AND CITY COUNCIL MEMBER PLACE 5 ELECTIONS; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Ordinance No. 26-1004 was approved on February 12, 2026, authorizing a General City Election on May 2, 2026, for the purposes of electing a City Council Member for Place 3, a City Council Member for Place 4, and a City Council Member for Place 5 into office; and

WHEREAS, pursuant to the Texas Election Code, Section 2.052, Certification of Unopposed Status, the authority responsible for having the official ballot prepared shall certify in writing that a candidate is unopposed for election to an office, enclosed hereto as Exhibit A. The certification shall be delivered to the governing body as soon as possible after the filing deadlines for placement on the ballot and list of write-in candidates; and

WHEREAS, pursuant to the Texas Election Code, Section 2.053, Action on Certificate, upon receipt of the certification, the governing body shall declare each unopposed candidate elected to the office. If no election is to be held on Election Day by the political subdivision, a copy of the order or ordinance shall be posted on Election Day at each polling place used or that would have been used in the election; and

WHEREAS, the governing body of a municipality may declare unopposed candidates elected to office and cancel the election if the number of candidates for an office does not exceed the number of positions to be filled; and

WHEREAS, the City Secretary has certified that the following candidates are unopposed in the May 2, 2026, General City Election:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HUMBLE TEXAS:

SECTION 1. The City Council hereby finds and determines that the following candidates, who are unopposed in the May 2, 2026, General City election, are declared elected to office:

<u>Candidate</u>	<u>Office Sought</u>
Bruce Davidson	Council Member Place 3
Paula Settle	Council Member Place 4
Rick Swamson	Council Member Place 5

SECTION 2. A certificate of election shall be issued to each candidate in the same manner and at the same time as provided for a candidate elected at the election. The candidate must qualify for the office in the same manner as provided for a candidate elected at the election.

SECTION 3. The May 2, 2026, City Council Member Place 3, City Council Member Place 4, and City Council Member Place 5 General Elections are canceled, and the City Secretary is directed to cause a copy of this ordinance to be posted on Election Day at each polling place used or that would have been used in the election.

SECTION 4. The May 2, 2026, General City Election for the offices of Councilmember Place 3, Councilmember Place 4, and Councilmember Place 5 is hereby canceled, and no election shall be held for these offices.

SECTION 5. This Ordinance shall take effect immediately upon its passage.


