IMPORTANT ELECTION DATES

GENERAL ELECTION OF CITY OFFICERS

May 7, 2022

Wednesday January 19, 2022	First day for filing an application for a place on ballot; and, first day for filing declaration of write-in candidacy for the General election.
Thursday February 10, 2022	January 24, 2022 to February 18, 2022 is the recommended period and statutory deadline for ordering the election. The City of Humble will order the election during the Thursday, February 10, 2022 regular City Council meeting at 6:30 p.m.
Friday February 18, 2022	Last day to file application for place on ballot in the General election. (Must be received by 5:00 p.m.)
Tuesday February 22, 2022	Last day for a write-in candidate to declare candidacy in the General election. (Must be received by 5:00 p.m.)
Friday February 25, 2022	Last day for a ballot candidate in General election to <u>withdraw</u> and have name removed. Last day for a write-in candidate in General election to <u>withdraw</u> and have name removed from write-in list. (Must receive in writing by 5:00 p.m.)
Monday February 28, 2022	Drawing for place on ballot at 9:00 a.m. at the City of Humble, Council Chambers, 114 W. Higgins St., Humble, Texas 77338. (All candidates will be notified if change in date is made.)
Thursday April 7, 2022	1st report of Candidate/Officeholder Campaign Finance Report due by 5:00 p.m., or midnight if filed electronically, by opposed candidates and specific-purpose committees supporting or opposing candidates. This is the 30-day prior to Election Day report.
Thursday April 7, 2022	Last day for submitting voter registration application to Harris County in time to vote at the election or for requesting transfer of registration in time to vote in new precinct not in the same county and territory.
Thursday April 7, 2022 to Wednesday April 27, 2022	April 7, 2022 to April 27, 2022 is the period for publishing the notice of election in the newspaper. Plans are to publish the notice in the Wednesday, April 13 and Wednesday, April 20 edition of the Humble Observer newspaper.
Sunday April 24, 2022 @ 6:00 p.m.	Candidate political signs may be posted throughout the City of Humble on city owned or controlled property starting at 6:00 p.m. It is an offense for any person to leave any electioneering sign or literature on city-owned or -controlled property that is used as a polling place other than during the period beginning on 6:00 p.m. before the voting period begins.
Monday April 25, 2022	First day for early voting by personal appearance begins.
Tuesday April 26, 2022	Last Day Harris County is to receive a vote by ballot application.
Friday April 29, 2022	2nd report of Candidate/Officeholder Campaign Finance Report due by 5:00 p.m., or midnight if filed electronically. This is the 8-day prior to Election Day report.
Tuesday May 3, 2022	Last day of early voting by personal appearance.

ELECTION DAY ** 7:00 a.m. to 7:00 p.m.

Monday May 9, 2022 @ 7:00 p.m.	Last day all candidate political signs must be removed throughout the City of Humble on city-owned or controlled property. It is an offense for any person to leave any electioneering sign or literature on city-owned or -controlled property that is used as a polling place other than during the period ending forty-eight (48) hours after the voting period ends.
Tuesday May 10, 2022	Recommended day to PROVIDE OFFICIAL OATH AND STATEMENT OF ELECTED OFFICIALS to candidates who appear to have won, or may win. These are provided for information only. THE OATHS ARE TAKEN AFTER THE CANVASS.
Wednesday May 11, 2022	Deadline for winning candidates to inform the City Secretary whom will be swearing them into office. (Must receive in writing by 5:00 p.m.) <i>The City Secretary's Office will confirm eligibly by or before the third business date.</i>
May 12, 2022	Overseas Ballots (Civilians) will be accepted through May 12, 2022 (5 days after Election Date)
May 13, 2022	Overseas Ballots (Military) will be accepted through May 13, 2022 (6 days after Election Date)
Tuesday May 10, 2022 to Wednesday May 18, 2022	PERIOD FOR OFFICIAL CANVASS. Harris County plans to have the results available to municipal entities contracting with the county by the close of business on Monday, May 16, 2022.
Wednesday May 18, 2022	Official canvass of returns – Special City Council Meeting <i>Last day for official canvass of returns by governing authority of political subdivision.</i>
Thursday May 26, 2022	Oaths of office for newly elected officers – Regular City Council Meeting at 6:30 p.m., unless runoff election is necessary.
Sunday May 15, 2022 to Monday May 23, 2022	ORDERING OF RUNOFF ELECTION, if necessary, not later than 5th day after canvass. A runoff candidate has until 5:00 pm of the 3rd day after the canvass to withdraw from the runoff election.
Monday May 30, 2022 to Tuesday July 5, 2022	POSSIBLE PERIOD FOR RUNOFF ELECTION, depending on date of official canvass, unless a charter provides for a later date. NOTE: NEW LAW (HB 88): The order of the names on the runoff ballot should be in the same order as they appeared on the general election ballot, no ballot drawing is required for the runoff ballot.
January 15, 2023 & July 15, 2023	Semi-annual statement of campaign contributions and expenditures by candidates and officeholders due.
