Presentation, possible action, and discussion on the approval of Ordinance No. 22-931, an ordinance amending Chapter 32 "Second Hand Goods," Article III "Precious Metals and Gems Dealers" of the Code of Ordinances of the City of Humble, Texas, relating to metal recyclers and secondhand resellers; declaring certain conduct to be unlawful and providing a penalty therefor; containing findings and other provisions relating to the foregoing subject; providing for severability; and providing for an effective date.**
