

**CITY OF HUMBLE
NOTICE TO BIDDERS
BID 2022-02**

The City of Humble is requesting bids for the Artesian Well Restoration Project. This project will consist of the breakout and removal of existing concrete pool, coping, electric, plumbing, electric service; installation of two level pools as shown in drawing, including electrical service, meter can, breaker box, pool equipment on gunite pad, 6-foot wooden fence with gate around pool equipment, 4-flood lights, auto fill and overflow line, InteliFlo VSF waterfall pump on artesian well head, and secure all permits required by the City of Humble.

Sealed bids, in duplicate, addressed to the Chief Financial Officer, City of Humble, 114 West Higgins, Humble, Texas, 77338 shall be labeled "Sealed Bid Number 2022-02 DO NOT OPEN" to be received no later than 2:00 PM, local time, on Thursday, May 26, 2022. Bids received after that time will not be accepted. Bids will be opened publicly and read aloud at that time in the City Council Chambers.

A Pre-Bid conference will be held at 10:30 AM, local time, on Wednesday, May 18, 2022 at the City of Humble City Hall, 114 West Higgins, Humble, Texas 77338. Attendance at the Pre-Bid conference is not mandatory. Deadline for submitting written requests for clarifications will be Friday, May 20, 2022 at 5:00 PM.

It is the sole responsibility of the bidder to ensure that his/her bid is actually in the City of Humble, Chief Financial Officer's office prior to the expiration of the time and date above first written.

Bid security in the amount of five (5) percent of the greatest amount bid must accompany each bid as a guarantee that the bidder will enter into a contract and execute the required bonds within ten (10) days after notice of award. Bids without such guarantee will not be considered. Bids will be required to be submitted under a condition of irrevocability for a period of ninety (90) days after bid opening.

It shall be each bidder's sole responsibility to inspect the site of the work and to inform him/herself regarding all local conditions under which the work is to be done. It shall be understood and agreed that all such factors have been thoroughly investigated and considered in the preparation of the bid submitted.

The Contractor and all Subcontractors for this project will be required to pay not less than the prevailing wage rates for the area of the project as determined by the Owner and listed in the project manual.

Upon consideration of the proposals, the City Council plans to award a Contract; however, the City reserves the right to reject any and all bids, to waive any and all formalities and technicalities, and to accept any bid which it deems advantageous to the City. Each bidder agrees to waive any claim it has or may have against the Engineer, the City and their respective agents and/or employees arising out of or in connection with the administration, evaluation or recommendation of any bid. The successful bidder will be required to furnish a performance bond and payment bond in an amount of 100% of the total contract price.
