THE CITY OF HUMBLE IS SOLICITING A REQUEST FOR QUALIFICATIONS FROM INTERESTED QUALIFIED ENGINEERS TO PROVIDE INITIAL ENGINEERING AND DESIGN SUPPORT, BID AND CONTRACT AWARD SUPPORT, CONTRACT MANAGEMENT AND CONSTRUCTION OVERSIGHT AND OTHER SPECIALIZED SERVICES RELATED TO THE DESIGN AND CONSTRUCTION OF IMPROVEMENTS TO G 103-44-00 BETWEEN 7TH STREET AND 1960 BYPASS AND G 103-43-04 BETWEEN COUNTRY VILLAGE AND TREBLE DR. AS PART OF THE CITY OF HUMBLE'S ARPA-SLFRF DRAINAGE IMPROVEMENT PROJECTS. FURTHER PROPOSAL INSTRUCTIONS AND SUBMISSION REQUIREMENTS WILL BE INCLUDED IN THE DETAILED REQUEST FOR QUALIFICATIONS. SEALED RESPONSES, IN TRIPLICATE, SHOULD BE ADDRESSED TO THE CHIEF FINANCIAL OFFICER, CITY OF HUMBLE, 114 WEST HIGGINS, HUMBLE, TEXAS 77338 AND SHALL BE LABELED "RFQ 2022-06 ARPA-SLFRF DRAINAGE IMPROVEMENT PROJECTS "DO NOT OPEN" AND SHOULD BE RECEIVED NO LATER THAN 2:00 P.M. ON SEPTEMBER 28, 2022. ONE DIGITAL COPY OF THE PROPOSAL SHALL BE INCLUDED IN YOUR SUBMITTAL. RFQ'S WILL BE OPENED PUBLICLY AT THAT TIME AT 114 WEST HIGGINS, HUMBLE, TEXAS, 77338.

IT IS THE SOLE RESPONSIBILITY OF THE RESPONDING PARTY TO ENSURE THAT HIS/HER PROPOSAL IS ACTUALLY IN THE CITY OF HUMBLE'S CHIEF FINANCIAL OFFICER'S OFFICE PRIOR TO THE EXPIRATION OF THE TIME AND DATE ABOVE FIRST WRITTEN.

ANY QUESTIONS OR REQUESTS FOR CLARIFICATION MUST BE SUBMITTED IN WRITING VIA EMAIL AT THE ABOVE ADDRESS AT LEAST FIVE (5) DAYS PRIOR TO THE DEADLINE.

UPON CONSIDERATION OF THE PROPOSALS THE CITY COUNCIL PLANS TO AWARD A CONTRACT; HOWEVER, THE CITY RESERVES THE RIGHT TO REJECT ANY AND ALL RFQ'S, TO WAIVE ANY AND ALL FORMALITIES AND TECHNICALITIES, AND TO ACCEPT ANY RFQ WHICH IT DEEMS ADVANTAGEOUS TO THE CITY. EACH SUBMITTER AGREES TO WAIVE ANY CLAIM IT HAS OR MAY HAVE AGAINST THE CITY AND THEIR RESPECTIVE AGENTS AND/OR EMPLOYEES ARISING OUT OF OR IN CONNECTION TO WITH THE ADMINISTRATION, EVALUATION OR RECOMMENDATION OF ANY RFQ.
