**ORDINANCE NO. 23-954**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HUMBLE, TEXAS, CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE GENERAL ELECTION HELD ON MAY 6, 2023 FOR THE PURPOSE OF ELECTING A MAYOR, A CITY COUNCIL MEMBER FOR PLACE 1 AND A CITY COUNCIL MEMBER FOR PLACE 2.**

WHEREAS, On January 26, 2023, the City Council ordered that a General Election be held on May 6, 2023 for the purpose of electing a Mayor, a City Council Member for Place 1 and a City Council Member for Place 2.

WHEREAS, Notice of this election was duly published in The Humble Observer on April 12, 2023; and

WHEREAS, A copy of the notice was posted on the bulletin board at City Hall on April 4, 2023; and

WHEREAS, This election was duly and legally held on May 6, 2023 in conformity with the election laws of the State of Texas, and the results of the election have been certified and returned by the proper judges and clerks; and

WHEREAS, The City Council of the City of Humble, Texas with a quorum present for the purpose of canvassing, have today considered the returns of the General Election held on May 6, 2023; and

WHEREAS, It appears to the Council, and the Council finds, that the election was in all respects lawfully held; and

WHEREAS, It appears to the Council, and the Council finds, that the tabulation of the results of the election are correct and attached hereto as Exhibit A; now therefore,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HUMBLE, TEXAS, THAT:**

Section 1. The General Election of May 6, 2023 was duly called, notice of the election was given in accordance with law, and the election was held in accordance with law.

Section 2. The tabulation of votes cast in the General Election held on May 6, 2023, for the purpose stated in Recital I above, a copy of which is attached hereto and made a part of this ordinance, is adopted as the official tabulation of the votes cast at the election, and the tabulation will be filed and recorded in the official records of the City of Humble as the official canvass of the election.

Section 3. The official canvass of the returns of the election reflects the following:

 Council Member Place 2: Mike Marshall

Section 5. In the event any clause phrase, provision, sentence, or part of this Ordinance or the application of the same to any person or circumstances shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair, or invalidate this Ordinance as a whole or any part or provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City of Humble, Texas, declares that it would have passed each and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, whether there be one or more parts.
