THE CITY OF HUMBLE IS REQUESTING COMPETITIVE SEALED PROPOSALS FROM INTERESTED CONTRACTORS TO REPLACE EXISTING CHAIN LINK FENCING, ENTRANCE GATES, AND WALKTHROUGH GATES AT HIRSCH PARK WITH 6' BLACK POWDER COATED IRON FENCING AND GATES; INSTALL 10' BLACK VINYL CHAIN LINK FENCING AROUND HIRSCH PARK TENNIS COURTS; INSTALL 6' BLACK POWDER COATED IRON FENCING WITH ENTRANCE AND WALKTHROUGH GATES AROUND HIRSCH PARK POOL; INSTALL 6' BLACK POWDER COATED IRON FENCING AND WALKTHROUGH GATES AT PARKS DEPARTMENT FACILITY. ON WEDNESDAY, SEPTEMBER 13, 2023.** BIDS WILL BE OPENED PUBLICLY AND READ ALOUD AT THAT TIME IN THE CITY COUNCIL CHAMBERS.



EACH BIDDER AGREES TO WAIVE ANY CLAIM IT HAS OR MAY HAVE AGAINST THE CITY AND THEIR RESPECTIVE AGENTS AND/OR EMPLOYEES ARISING OUT OF OR IN CONNECTION TO WITH THE ADMINISTRATION, EVALUATION OR RECOMMENDATION OF ANY BID.
