ORDINANCE NO. 24-968

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HUMBLE, TEXAS, CANVASSING THE RETURNS OF THE GENERAL ELECTION OF MAY 4, 2024 FOR THE PURPOSE OF ELECTING THE CITY COUNCIL MEMBERS FOR PLACES 3, 4 AND 5.

- WHEREAS, On February 8, 2024, pursuant to Ordinance 24-962, the City Council ordered that a General Election be held on May 4, 2024, for the purpose of electing a City Council Member for Place 3, a City Council Member for Place 4, and a City Council Member for Place 5; and
- WHEREAS, Notice of this election was duly published in The Humble Observer on April 10, 2024; and
- WHEREAS, A copy of the notice was posted on the bulletin board at City Hall on April 8, 2024; and
- WHEREAS, This election was duly and legally held on May 4, 2024, in conformity with the election laws of the State of Texas, and the results of the election have been certified and returned by the proper judges and clerks; and
- WHEREAS, The City Council of the City of Humble, Texas with a quorum present for the purpose of canvassing, have today considered the returns of the General Election held on May 4, 2024; and
- WHEREAS, It appears to the Council, and the Council finds, that the election was in all respects lawfully held; and
- WHEREAS, It appears to the Council, and the Council finds, that the tabulation of the results of the election are correct; now therefore

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HUMBLE, TEXAS, THAT:

Section 1. The General Election of May 4, 2024 was duly called, notice of the election was given in accordance with law, and the election was held in accordance with law.

Section 2. The official canvass of the returns of the election reflects the following:

Section 3. That the results of said general City election be and the same are hereby declared to have been as herein set out, and the following named persons are to serve in the respective positions listed subject to the taking of the oath of office as provided by the laws of the State of Texas:


Council Member Place 3: Bruce Davidson

 Council Member Place 5: Rick Swanson

Section 4. In the event any clause phrase, provision, sentence, or part of this Ordinance or the application of the same to any person or circumstances shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair, or invalidate this Ordinance as a whole or any part or provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City of Humble, Texas, declares that it would have passed each and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, whether there be one or more parts.
