The City of Humble is requesting bids for the North Hollow Subdivision Joint and Crack Sealing Project. This project involves furnishing and placing hot poured joint and crack sealant for concrete pavement streets located within the North Hollow Subdivision in the City of Humble, as well as all labor, equipment, materials, and incidentals required for the project.

Sealed bids, in duplicate, addressed to the Chief Financial Officer, City of Humble, 114 West Higgins, Humble, Texas, 77338 shall be labeled "Sealed Bid Number 2024-03 DO NOT OPEN" to be received no later than 2:00 PM, local time, on Tuesday, July 30, 2024. Bids received after that time will not be accepted. Bids will be opened publicly and read aloud at that time in the City Council Chambers.

It is the sole responsibility of the bidder to ensure that his/her bid is actually in the City of Humble, Chief Financial Officer's office prior to the expiration of the time and date above first written.

BID SECURITY IN THE AMOUNT OF FIVE PERCENT (5%) OF THE GREATEST AMOUNT BID MUST ACCOMPANY EACH BID IN ACCORDANCE WITH THE GENERAL INSTRUCTIONS TO BIDDERS. BIDS WILL BE REQUIRED TO BE SUBMITTED UNDER A CONDITION OF IRREVOCABILITY FOR A PERIOD OF NINETY (90) DAYS AFTER BID OPENING. THE SUCCESSFUL BIDDER WILL BE REQUIRED TO FURNISH A PERFORMANCE BOND, PAYMENT BOND, AND MAINTENANCE BOND IN AN AMOUNT OF 100% OF THE TOTAL CONTRACT PRICE. THE SUCCESSFUL BIDDER WILL BE REQUIRED TO FURNISH INSURANCE THAT MEETS ALL REQUIREMENTS AS SET FORTH IN THE PROJECT MANUAL WITH THE CITY OF HUMBLE NAMED AS ADDITIONAL INSURED.

It shall be each bidder's sole responsibility to inspect the site of the work and to inform him/herself regarding all local conditions under which the work is to be done. It shall be understood and agreed that all such factors have been thoroughly investigated and considered in the preparation of the bid submitted.
