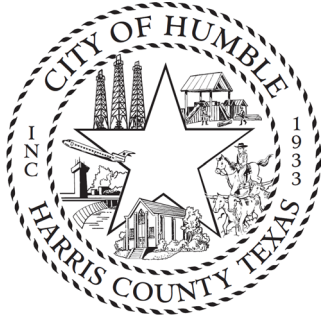
Call to order.
